
Subject: Government sanction to observe the "Study Tour" to be held from 10-19 January 2017 or nearest possible date in the Philippines.


- All of expenses related to their participation will be borne by the Secondary Education Quality and Access Enhancement Project (SEQAEP), Dhaka.
